

# **MASKING PROTOCOL**

### Introduction:

This policy details the requirements concerning mask usage within Paramount Global facilities, productions and events.

## Applicability & Scope:

This masking protocol applies to staff, project-based employees (PBE), clients, guests, talent, press, and others within all Paramount Global business operations. Employees at non-Paramount Global facilities, events, productions, etc. for work-related activities are expected to adhere to this policy. There are less stringent masking protocols documented in this policy specific to production, yet if there is a local mandate or regulation not referenced in this policy that has more stringent requirements than our company protocols, the local mandate will take precedent.

## **Definitions:**

Fully Vaccinated indicates the following:

- 1. A complete vaccine series with a CDC or WHO approved vaccine has been received:
  - a. 1 shot of single dose series, or
  - b. 2 shots of all other vaccines that require two doses
- 2. Two weeks have elapsed since series has been completed
- 3. Productions covered under the Return-To-Work union agreement are considered fully vaccinated and "up-to-date" with a complete vaccination series and a booster shot.

<u>Masks</u> – a face covering that meets the following criteria:

- 1. Two-ply fabric or disposable surgical mask or disposable N-95/KN-95 mask
- 2. Has straps that go around the ears or go behind the head.
- 3. Masks with valves, bandanas and gators are not permitted.

**Proper Mask Fit** – A mask is properly worn when it covers the mouth, nose and chin.

## Mask Wearing Culture at Paramount Global

To promote a safe culture within the workplace, the following will apply:

1. Any person should always feel free to wear a mask or request others to wear a mask in their presence without fear of reprisal or shaming, as people will have different motives to wear a mask or protect themselves.







2. Wearing a mask within Paramount Global facilities and environments is a collectively shared social responsibility to protect each of us in the workplace. Please remember that people may choose to wear a mask to protect themselves or loved ones at home.

## When to wear a mask:

- 1. <u>Mask wearing is welcome but not required for those who are fully vaccinated</u>, EXCEPT:
  - a. When required by the Return-To-Work Agreement for productions, or
  - b. When mandated by a venue, or applicable local guidance
- 2. <u>Masks must ALWAYS be worn by any unvaccinated person or anyone who has</u> <u>not disclosed their vaccination status (i.e., in the state of TN)</u>, even when seated at their cubicle/workstation, unless they are actively eating or drinking.
- 3. Paramount Global staff are responsible for ensuring that their visitors/guests are masked when required.

## **Special Circumstances**

- Isolation & Quarantine There are specific instances for masking after testing positive for Covid or being identified as a close contact. The masking protocols are identified in the <u>Contact Tracing</u>, <u>Post Exposure and Positive Diagnosis Policy</u>.
- 2. Return-To-Work Agreement for productions requires the wearing of mask at all times regardless of vaccination status The following approved masks will be made available by Paramount Global to all cast & crew as well as and any individuals working on behalf of the company in the production environment:
  - a. KN95 or KF94
  - b. N95 (it is recommended that this mask should only be used by medical or health professionals)
  - c. Surgical/Medical grade masks must have an adjustable nose-wire and be made of at least three layers of non-woven material (melt blown fabric and/or polypropylene but shall only be worn when a proper fit with the masks listed above cannot be achieved.
  - d. A cloth mask may only be used in double masking, when on the outside of a surgical mask.
