### VIACOMCBS PRIVACY NOTICE FOR ENTITIES IN THE EEA AND SWITZERLAND

### UPDATED: January 20, 2021

This notice describes the personal data that ViacomCBS Inc. ("ViacomCBS", "we", "us" or "our") and its entities in the UK, European Union and Switzerland may collect about individuals, specifically with respect to the re-opening of our offices, productions and other sites (collectively, the "Sites") as staff begin to return to our Sites following the outbreak of the novel coronavirus 2019 n-CoV ("COVID-19").

Please note that this notice applies to our employees and also to other individuals who carry out work for us such as freelancers, consultants or talent that we engage. In this notice, we refer to this broader group of persons as 'Employees' for ease. Section I, II, IV, V and VII of this notice may also apply to employees, contractors and agents of our third-party productions, so far as they access our Sites.

In particular, this notice explains:

- what personal data we collect;
- why we process your personal data;
- the legal grounds which allow us to process your personal data; and
- who gets to see your personal data.

#### I. PERSONAL DATA – WHAT WE COLLECT AND WHY WE PROCESS IT

COVID-19 is the infectious disease caused by the most recently discovered coronavirus. COVID-19 is highly contagious and spreads easily from persons who have the virus to other persons. In order to reduce the risk of spreading the illness among our Employees, as well as outside of our Employee population, ViacomCBS may collect and process certain personal data relating to your health and circumstances.

As you know, in early 2020, in response to the outbreak and spread of COVID-19, ViacomCBS closed its Sites worldwide to non-essential employees. As we begin to gradually reopen our Sites we may process your personal data in accordance with our health and safety protocols and applicable law in order to minimize the risk of Employees contracting COVID-19 in our workplace.

Specifically, where permitted by applicable law, we may request, and in certain cases, require, that you participate in one or more daily health screenings prior to entering any of our Sites. Please refer to the appendix specific to your Site for further information on the testing that we may implement. To date, such health screenings may include:

- (1) a health questionnaire (the "Health Check"); and
- (2) an on-site or at-home temperature check ("Temperature Check"); and
- (3) diagnostic testing for COVID-19 ("Diagnostic Tests").

### Health Check Data

We may process the following personal data about you by virtue of the Health Checks: your name, department, business email address, the date(s) you will be on Site, and whether you have answered affirmatively to any questions about whether you or anyone in your household has or has been exposed to COVID-19, has certain COVID-19 related symptoms, has travelled internationally, works in the healthcare industry or otherwise was exposed to positive COVID-19 patients.

We may also ask (be it as part of any Health Check or separately) whether you or a member of your family are particularly vulnerable to the virus, for example due to having certain health conditions.

Please note that we will not process your personal data unless necessary for our purposes. Normally, the only information that we will record will be whether you have answered *affirmatively* to any of the Health Check questions. However, in some cases (such as where you have identified yourself as being particularly vulnerable) we may need to seek further details from you.

### Temperature Check Data

We may process the following personal data about you during the Temperature Check: your name, department, business email address, the date of the check, and whether your body temperature is at or greater than 38°C (100.4°F) (together with data described in "Health Check Data" and "Diagnostic Test Data", referred to as the "Health Data"). We will normally only process data where your temperature meets or exceeds the relevant threshold.

#### Diagnostic Test Data

In connection with our productions, we (or the production companies with which we partner in the respective territories) may ask you to participate in diagnostic testing (namely, Covid-19 PCR Rapid Molecular Testing or any analogous medical tests) before entering into specific production Sites. We may also offer diagnostic testing, on a voluntary basis, to non-production Employees who need to enter our Sites.

Any such testing will be facilitated by an external health service provider and carried out by qualified doctors, nurses or other trained medical personnel engaged on our behalf ("Health Providers") or on behalf of our local production partners. These Health Providers will only process limited data about you in a confidential and secure manner and, in some instances and subject to the applicable local laws, will notify us of any positive results and/or whether you are not approved to enter the Site. When relevant, limited ViacomCBS staff may be able to access positive testing results in order to ensure health and safety in the production Sites and take any necessary steps, including by sharing test results with public health authorities to the extent required by local laws.

#### II. WHAT WE WILL DO WITH THE DATA

The data collected will be used to ensure that we keep our Sites as safe as possible.

In the event that:

- you inform us, or a Diagnostic Test indicates, that you have (or someone in your household has) been positively diagnosed with COVID-19 and you have entered the Site and/or been in contact with other Employees;
- you inform us, or a Diagnostic Test indicates, that you have (or someone in your household has) been positively diagnosed with COVID-19 but have <u>not</u> entered the site, or have had contact with other employees;
- you inform us that you have (or someone in your household has) symptoms of COVID-19;
- you inform us that you are (or someone in your household is) particularly vulnerable to the virus; or
- we record a body temperature above 38°C (100.4°F).

we may take **one or more** of the following actions, **as relevant**:

 notify the other Employees or individuals who might have been exposed to you and/or update our intranet with a list of the building and floor on which the office of a positively-diagnosed Employee is located.

This is especially important information for our staff who may be particularly vulnerable to the virus, or who have vulnerable family members who they may then need to isolate from. Please note that when notifying other individuals of potential exposure, **we do not** share your name or any identifiable personal data unless required by the local health authority or if you give us express permission; we only inform them that we understand that they have come into contact with someone with a positive diagnosis. As such, if we tell you we believe you have been in contact with someone with the virus, please understand that we cannot confirm or deny the specific person;

- reach out to discuss next steps, including self-isolation measures;
- seek more information from you in order to discuss with you options to mitigate the risks the virus poses to you and/or someone in your household;
- request that you carry out your duties off-site (to the extent this is possible); and
- record any action taken as above.

### III. WHAT ARE THE LEGAL GROUNDS FOR PROCESSING YOUR HEALTH DATA?

A summary of the grounds for processing personal data under applicable data protection law is available in the legacy Viacom Workplace Privacy Notice (the "WPN"), which is available <u>here</u>, or in the applicable legacy CBS Workplace Privacy Notice (the "CBS WPN"), which you can request from your local Human Resources representative. In addition, you may refer to our COVID-19 Privacy Notice dated March 27, 2020, available <u>here</u>.

In this case we process your data in order to comply with our legal obligation to safeguard our Employees. Additionally, as your Health Data is special data, before processing it, we ensure that the processing is necessary for the purposes of carrying out our obligations and exercising our rights in the field of employment, social security or social protection law. In this case we have an obligation to ensure a safe place of work and a general duty of care to all our staff. We also believe that such processing is necessary for reason of substantial public interest.

In certain jurisdictions, we may also process your data on the basis of the Employee's consent and to comply with any relevant sanitary protocols provided by the local authorities/administrations/federations.

### IV. WHO SEES YOUR HEALTH DATA?

Your Health Data will be processed by and/or shared with a limited group of critical ViacomCBS personnel, all of whom are members of ViacomCBS' COVID-19 response team and some of whom are located in the United States. For further information about how and why we transfer your personal data outside of the UK or EEA generally, please refer to the WPN or CBS WPN, as applicable.

Your Health Data may also be shared with your supervisor(s), and with public health authorities to the extent required by local laws.

Otherwise, as mentioned above, in the event of a positive diagnosis, we may inform work-related individuals who you may have come into contact with **on an anonymous basis**, and, if relevant, critical personnel of ViacomCBS productions and its production partners, and union or guild representatives, **on a confidential and need-to-know basis**.

### V. HOW LONG DO WE RETAIN YOUR PERSONAL DATA

As a general principle we will only keep your personal data for as long as it is necessary for the purposes set out above – i.e. to protect Employees and visitors and to keep our sites safe. This may depend on how long the COVID-19 pandemic lasts, relevant government guidance, and scientific developments. For example, as information on immunity develops we may keep data on who has had the virus (and so is likely to be immune) to allow us to better manage risk.

In some circumstances, your data may be kept where necessary for legal purposes or for the for the establishment, exercise or defence of legal claims.

### VI. OTHER INFORMATION

The Health Data will be kept securely and – save as above - will not be used for purposes outside of dealing with the COVID-19 crisis.

### VII. STATUS OF THIS NOTICE

For the avoidance of doubt, this notice does not form part of your contract of employment and does not create contractual rights or obligations. It may be amended by us at any time. Nothing in this notice is intended to create an employment relationship between ViacomCBS and any non-employee.

### **Testing for Production Sites**

In addition to the above, in certain **Production Sites**, specific circumstances and in certain cases, we may require that you participate in testing (namely, Covid-19 PCR Rapid Molecular Testing or any analogous medical tests, "Covid-19 Testing") before entering into the specific Production Sites. We may also offer voluntary testing to non-production Employees who are required to enter our Sites. Testing will be facilitated by our External Health Service providers (Fleet Street Clinic and World Extreme Medicine and any other ones that we may contract in the future with the appropriate safeguards in place) and carried out by qualified doctors and nurses.

Our External Health Service providers will only process limited data about you in a confidential and secure manner and will notify us of the results. Pursuant to applicable law, such data may include name, sex, date of birth, NHS number, ethnicity, address, telephone number, and email address, in addition to the Health Data. Limited ViacomCBS staff will be able to access testing results in order to ensure health and safety in the Sites and take any necessary steps as explained above. including sharing results with public health authorities to the extent required by local laws.
